John Womack, son of William who died 1777/8 in Halifax Co., N. Co. settled in the 1760's or 1770's in Chatham County, North Carolina (Chatham County formed 1771 from Orange County). Chatham County court minutes for 1778 listed John Wommock on a road jury. John Womack married around 1770(?) to Elenor Rorie, daughter of John Rorie of Halifax Co., No Co (The will of John Rorie, Sr., Halifax Co, NC, Will Book 3, page 31, named, among others, son-in-law John Womack, and four grandchildren, heirs of daughter Elenor Womack: James, Aner, Martha,, and Rorie Womack, Will dated 7 July 1782, probated Aug 1782.) After the death of his first wife, Elenor Rorie, John Womack took a common law wife, Susannah Allen, John Womack and family lived in that section of Chatham County which fell into Lee County, No C., in 1907, in the easternmost point of Lee County, near the Chatham County line and the Harnett County line, and about six miles northeast of the town of Broadway in Lee County. John Womack also owned land across the county line in Moore County (Moore County deeds destroyed up to 1889), but in that section of Moore County which fell into Lee County in 1907. John lived in Caswell Co, NC during the Revolutionary War. He received final war settlement in 1790, member of NC General Assembly, member legislature from Caswell Co, in 1787, House of Common form Person Co, in 1792. Elected to the Senate in 1800. All the land in North Carolina once belonged to the State (to the Crown in colonial days), but most of it has been granted the past three hundred years, a few acres at a time, to those settlers who applied for it and paid the required fee of a few cents per acre. There is a total of nearly a quarter of a million land grants on record in the Land Grant Office, Raleigh, North Carolina, ranging in size from a fraction of an acre to several thousand acres, but averaging between 100 and 150 acres per grant. Of the 32 million acres in North Carolina, 28 million acres were privately owned in 1950, and 4 million acres were public lands. The tillable and habitable acreage-the 28 million acres--was all taken up generations ago. A search through the files at the Land Grant Office revealed that between 1760 and 1910 three dozen grants were issued to various members of the Womack family. Notes for George Barber:

Oglethorpe County, in northeast Georgia, is the state's seventeenth county and comprises 441 square miles. Creek and Cherokee Indians lived there when the first white people arrived, but they lost their land through treaties signed in 1773. Fur trappers and traders traversed the area before the first non-Indians

established permanent settlements. A few trappers established a temporary community known as Kennedy's Gate, but it was no longer extant by the time of the American Revolution (1775-83). At first the area was all part of Wilkes County, but Oglethorpe County, named for Georgia's founder James Oglethorpe, was carved from Wilkes in 1793 to accommodate population growth. Over the years Oglethorpe County has gained land from surrounding counties, sometimes in exchange for parts of itself. The first permanent white settlers, led by Revolutionary War veteran Colonel George Mathews to Georgia after the war, were a group of wealthy tobacco planters from Virginia. Residents later moved into cotton production with the invention of the cotton gin and the construction of railroads, which greatly assisted marketing efforts. After the plantation system lost its profitability in the aftermath of boll weevils, fire, war, and emancipation, the county's agriculture shifted to small farms, often operated on the sharecropping system. Grain, poultry, beef, and dairy cattle were among the county's major farm products. Farm income was augmented by employment in the lumber, granite, and textile industries.

Formed originally as Henrico Shire, and shortly thereafter termed a "county," Henrico County was named for Henricus founded in 1611 by Sir Thomas Dale, a settlement wiped out during the Indian Massacre of 1622. Cape Henry at the southern mouth of the Chesapeake Bay, Henricus, Henrico Cittie, and later Henrico County, were all named for Henry Frederick, Prince of Wales, the eldest son of James I of England. Prince Henry showed great promise, and his death from typhoid fever at the age of eighteen was regarded as a tragedy for England. On, November 18, 1618, the Virginia Company of London, proprietor of the colony, gave instructions on the formation of a laudable government for the Colony to Sir George Yeardley when he departed from London to become full governor of Virginia. As directed, in 1619, Governor Yeardly established four large corporations, termed cities [sic], which were designated to encompass the developed portion of the colony. These were Kecoughtan (later renamed Elizabeth Cittie), James Cittie, Charles Cittie, and Henrico Cittie. In 1634, the King of England ordered the colony, which numbered about 5,000 settlers, to be divided into eight shires, or counties. One of these original shires (of which six are still considered extant) was Henrico County. Henrico County originally extended to both the north and south sides of the James River (named in 1607 for King James I). Henrico's first boundaries incorporated an area from which 10 Virginia counties were later formed in whole or in part, as well as the independent cities of Richmond, Charlottesville, and Colonial Heights. The original site of Henricus was located by archeologists late in the 20th century. On the south side of the James River (across from the original site of Varina, it is now in Chesterfield County, which developed Henricus Historical Park there.

Notes for "Jno" Jonathan Aekin:

Varina (Va-ry-nah), VA is a former unincorporated town and current magisterial district in the easternmost portion of Henrico County, Virginia, United States. Varina was named for Varina Farms, a plantation established by John Rolfe on the James River about 45 miles upstream from the first settlement at Jamestown in the Virginia Colony, and across the river from Sir Thomas Dale's 1611 settlement at Henricus. Varina became the county seat of Henrico when it was formed as one of the eight original shires of Virginia in 1634, and remained in that capacity until 1752, when a new courthouse was built at In 1612, English colonist John Rolfe introduced the cultivation of a special strain of tobacco for export to England, which was much better-liked by the Europeans than a harsher form which grew naturally in Virginia. As his tobacco became a cash crop for the struggling colony's economy, he established a plantation estate at Varina Farms about 45 miles upstream from the first settlement at Jamestown and across the river from Sir Thomas Dale's 1611 settlement at the progressive community at Henricus. Henricus was developed as a potential replacement for the shortcomings of the Jamestown location. Varina Farms Plantation was named for a mild variety of the tobacco from Spain which was similar to the non-native strain Rolfe used in developing his successful product. The plantation became the home of Rolfe and his second wife, Pocahontas, the daughter of Chief Powhatan, head of the Native American Powhatan Confederacy for two years following their marriage in 1614. It was the birthplace of their son, Thomas Rolfe in 1615. The area which included Varina Farms Plantation was part of Henrico Cittie (sic), an incorporation formed in 1619 by the Virginia Company of London. Henricus was clearly the central development of Henrico Cittie. However, although Henricus was wiped out and not rebuilt after the Indian Massacre of 1622, a tiny village grew up on Rolfe's Plantation which was called both "Varina" and "Henrico Parish". When the original eight shires of Virginia (later renamed counties) were formed in 1634, Varina became the county seat of Henrico. Varina was established as an unincorporated town in 1680. It featured a courthouse, a church for Henrico Parish, and commercial buildings, such as a tavern. The Henrico Glebe house at Varina was the location where Reverend Dr. James Blair is believed to have drawn up the plans for new school which became the College of William and Mary in 1693 after his mission to England at the request of the House of Burgesses. The royal charter for the new school resurrected one of the dreams of the colonists which had been lost at Henricus in 1622.

Notes for William Wallace:

In 1616-1618, William Wallace stands first in the list of masons at Edinburgh Castle and was paid for making moulds for plasteres and carving window-boards in additions to a cartouche over a doorway that is noted as an accomplished specimen of Netherlands strapwork dated 1615 and stamped with Wallace's mark. It is not assumed that William Wallace was necessarily the chief agent in the change in style which is seen in so many Scottish buildings after 1615, but he is certainly the representative figure, and the style issues from the official quarter where he was the senior artificer. The reconstruction of Linlithgow Palace (dated 1619 and 1620) is also credited to William Wallace. Although, Wallace's most famous and significat building was begun eight years later. Heriot's Hospital at Edinburgh was founded under the will of George Heriot for the education of fatherless boys. He beagan it in 1628, but died before it's completion in 1631. William Wallace died in 1631, but his style long survived him. Already in his lifetime it was caricatured at Caerlaverock (1620) and well imitated in 1628 at Moray House, Edinburgh, the town-house of a Countess of Home.

Notes for Lawrence Womack:

Early in Henry VII's reign, the Royal pretender, Perkin Warbeck, besieged Exeter in 1497. The King himself came down to judge the prisoners and to thank the citizens for their loyal resistance. Great disturbances throughout the county followed the introduction of Edward VI's Book of Common Prayer. The day after Whit Sunday 1549, a priest at Sampford Courtenay was persuaded to read the old mass. This insubordination spread swiftly into serious revolt. The Cornish quickly joined the men of Devon in the Prayer Book Rebellion and Exeter suffered a distressing siege until relieved by Lord Russell. Devon is particularly known for its Elizabethan mariners, such as Sir Francis Drake, Gilbert, Sir Richard Grenville and Sir Walter Raleigh. Plymouth Hoe is famous as the location where Drake continued to play bowls after hearing that the Spanish Armada had been sighted. Plymouth was the departure point for the Mayflower in 1620. During the Civil War, Devon largely favoured the Parliamentarian cause, but there was a great desire for peace in the region and, in 1643 a treaty for the cessation of hostilities in Devon and Cornwall was agreed. Only small-scale skirmishes continued until the capture of Dartmouth and Exeter in 1646 by Sir Thomas Fairfax. He then captured Tiverton and defeated Lord Hopeton's army at Torrington. The last place held for the king was Charles Fort at Salcombe. After the Monmouth Rebellion in 1685, Judge Jefferies held one of his 'bloody assizes' at Exeter. In 1688, the Prince of Orange first landed in England at Brixham (where his statue stands in the town harbour) to launch the Glorious Revolution and his journey to London to claim the English throne as William III. He was entertained for several days at both Forde and at Exeter.

Notes for William Wallace:

Wallace of Elderslie (1) The name 'Wallace' (probably derived from Galleius, with many variations such as Walleis) is believed to imply that this family originated in either Wales or (perhaps more likely) the Cymbric (Cimbric) kingdom of Strathclyde which at one time covered much of the middle-western half of Great Britain. It is thought likely that the family was one of the many that made a mark in Scotland in King David's 'administrative revolution' in the second quarter of the 12th century. However, it is not clear how long the family had been in Scotland by that time - it may have come to Scotland shortly before or even during King David's reigh (1124-1153). (2) Much interest has been focused on this family because of its most famous son, Sir William Wallace, who was Guardian of Scotland during a key part of 'The Wars of Independence'. However, rather than help clarify the genealogy of the family, that interest has managed to obscure it because so many contradictory descents have been produced. To date no 'definitive' pedigree has yet been found.

Notes for Hugh Crawford:

Kilbirnie (Gaelic Cille Bhraonaidh) is a small town situated in North Ayrshire on the west coast of Scotland. Kilbirnie derived its name from the parish church and the church obtained its name from the saint to whom it was dedicated; the celtic Cil, pronounced Kil, signifying a church, being prefixed to the name of the saint; St Birinie, or Birinus, is said to have been a bishop and confessor who converted the West Saxons. In the early years of Mary Queen of Scot's reign, foreign invasions were a constant threat. The English wanted more than soothing diplomacy from the Queen Mother - Mary of Guise - they wanted custody of little Mary herself, in order to marry her to their child-king Edward VI. The result was another in the series of invasions known to later history as 'the Rough Wooing' and the catastrophic Scots defeat at the battle of Pinkiecleuch, on 10 September 1547. William Patten, a Londoner (as he proudly styles himself on the title page of his work), came to Scotland with the invasion force and saw for himself the dreadful carnage left in the wake of the successful English assault. To the Scottish Catholic church, the English invaders were heretics, and a good turn-out of church men and their vassals was a feature of the Scottish side. Alas, the Kirk militant had little success. The battle was a disaster, with casualties greater than at Flodden. Mary had

to be spirited to safety at the island priory of Inchmahome whilst arrangements were made to evacuate her Soon after this notable strewing of their footmen's weapons, began a pitiful sight of the dead corpses lying dispersed abroad, some their legs off, some but houghed, and left lying half-dead, some thrust quite through the body, others the arms cut off, diverse their necks half a sunder, many their heads cloven, of sundry the brains pasht out, some others again their heads guite off, with other many kinds of killing. After that and further in chase, all for the most part killed either in the head or in the neck, for our horsemen could not well reach the lower with their swords. And thus with blood and slaughter of the enemy, this chase was continued five miles in length westward from the place of their standing, which was in the fallow fields of Inveresk until Edinburgh Park and well nigh to the gates of the town itself and unto Leith, and in breadth nigh 4 miles, from the Firth sands up toward Dalkeith southward. In all which space, the dead bodies lay as thick as a man may note cattle grazing in a full replenished pasture. The river ran all red with blood, so that in the same chase were counted, as well by some of our men that somewhat diligently did mark it as by some of them taken prisoners, that very much did lament it, to have been slain above 14 thousand. In all this compass of ground what with weapons, arms, hands, legs, heads, blood and dead bodies, their flight might have been easily tracked to every of their three refuges. And for the smallness of our number and shortness of the time (which was scant five hours, from one to well nigh six) the mortality was so great, as it was thought, the like aforetime not to have been seen. Indeed it was the better maintained with their own swords that lay each where scattered by the way, whereof our men, as they had broke one still took up another; there was store enough, and they laid it on freely, that right many among them at this business broke three or four ere they returned homeward to the army. I may well perchance confess, that herein we used some sharpness (although not as much as we might) and little courtesy, and yet I can safely avow, all done by us, as rather by sundry respects driven and compelled, then either of cruelty or delight in slaughter. And like someway to the diligent master that sharply sometime (when warning will not serve) doth beat his scholar, not hardly for hate of child, or his own delight in beating, but for love he would have him amend his faults or negligence and beats him once surely because he would need to beat him no more. One cause of the correction we used, I may well count to be their tyrannous yow they made (which we certainly heard of) that whensoever they fought and overcame, they would slay so many, and spare so few, a sure proof of whereof they plainly had showed at our onset before, where they killed all, and saved not a man. Another respect was to revenge their great and cruel tyranny shown at Panyarhough [the battle of Ancrum Moor, 1545 - a Scottish victory] where they slew the Lord Evers [Sir Ralph Eure] and cruelly killed as many else of our men as came in their hands . . . Another thing and not the meanest matter was that their armour amongst them so little differed, and their apparel so base and beggarly, wherein the Lurdein [rascal] was in a manner all one with the Lord, and the loun [commoner] with the laird: all clad alike in jacks covered with white leather, doublets of the same or of fustian and most commonly all white hose. Not one with either chain, brooch, ring or garment of silk that I could see, unless chains of latten drawn four of five times along the thighs of their hose and doublet sleeves for cutting; and of that sort I saw many. This vileness of port [appearance], was the cause that so many of their great men and gentlemen were killed and so few saved. The outward show, the semblance and sign whereby a stranger might discern a villein from a gentleman was not among them to be seen. As for words and goodly proffer of great ransoms, [they] were as common and rife in the mouths of the one as of the other. And therefore hereby it came to pass that after, at the examination and counting of the prisoners we found taken about above twenty of their villeins to one of their gentlemen: whom no man need to doubt, we had rather have spared, then the villeins, if we could have known any difference between them in taking. And yet notwith-standing all these our just causes and quarrels to kill them, we showed more grace and took more to mercy then the case on our side, for the cause aforesaid did well deserve or require . . . for the prisoners accounted by the Marshal's book were numbered to above 1500. Touching the slaughter, sure we killed nothing so many as (if we had minded cruelty so much) for the time and opportunity right well we might, for my Lord's grace, of his wonted mercy, much moved with the pity of this sight, and rather glad of victory, than desirous of cruelty, soon after (by guess) five of the clock stayed his standard of his horsemen at the furthest part of their camp westward and caused the trumpets to blow a retreat. Whereat Sir Ralph Sadler treasurer (whose great diligence at the time and ready forwardness in the chiefest of the fray before did worthily merit no small commendation) caused all the footmen to stay and then with much travail and great pain, made them to be brought into some order again. It was a thing yet not easily to be done, by reason they all as then somewhat busily applied their market to the spoil of the Scottish camp, wherein were found good provision of white bread, ale, oatcakes, oatmeal, mutton, butter in pots, cheese and in diverse tents good wine also; good store to say truth, of good victual for the manner of the country. And in some tents among them (as I heard say) were also found of silver plate a dish or two, 2 or 3 goblets and 3 or 4 chalices, the which the finders (I know not with what reverence but with some devotion hardly) plucked out of the cold clouts and thrust into their warm bosoms... It was a wonder to see, but that (as they say) many hands make light work, how soon the dead bodies were stripped out of their garments stark naked, even from as far as the chase went until the place of our onset; whereby the

personages of our enemies might by the way easily be viewed and considered; the which for tallness of stature, cleanness of skin, bigness of bone with due proportion of all parts, I for my part advisedly noted to be such, as but that I saw that it was so, I would not have believed sure so many of that sort to have been in all their country. Among them lay there many priests and kirkmen, as they call them, of whom it was bruited amongst us, that there was a whole band of 3 or 4 thousand, but we were after informed, it was not altogether so... Among these [the Scots] weapons and beside several other banners, standards and pennons, a banner of white sarcenet was found under which it was said these kirkmen came, whereupon was painted a woman with her hair about her shoulders, kneeling before a crucifix, and on her right hand a church; after that written a long upon a banner in great roman letters afflictae sponsae ne obliviscaris [Do not forget your afflicted spouse]; which words declared that they would have this woman to signify the church, Christ's spouse and thus in humble wise making her petition unto Christ her husband that he would not now forget her, his spouse, being scourged and persecuted, meaning at this time by us. It was said it was the Abbot of Dunfermline's banner; but whether it was his or the Bishop of Dunkeld's, the governor's brothers [brothers of the Regent Arran] (who I understand were both in the field) and what the number of kirkmen was, I could not certainly learn: but I was sure it was some devout papist's device, that not only be like would not endeavor to do ought for atonement and peacemaking between us, but all contrariwise brought forth his standard stoutly to fight in field himself against us; pretexting this his great ungodliness thus bent toward the maintenance of a naughty quarrel with colour of religion to come in aid of Christ's church. Which church to say truth, coming thus to battle full appointed with weapon and guarded with such sort of deacons to fight; however in painting he had set her out, a man might well think in that in condition he had rather framed a cursed quean [hussy] that would pluck her husband by the pate except she had her will, than like a meek spouse that went about humbly by submission and prayer to desire her husband's help for redress of things amiss. Colin Campbell, 6th Laird of Glenorchy and son of Sir George Campbell, was called Grey Colin for the color of his hair and beard. He expanded the power of his branch of Clan Campbell eastward through the Glens of Breadalbane and up against the land's of the Stewart Earls of Atholl in Perthshire. What better way to consolidate and secure his eastern borders than to arrange the marriage of his son 'Black' Duncan Campbell with Janet Stewart, daughter of the 4th Earl of Atholl?

In 16th Century Scotland, an earl was roughly two or three ranks above a laird and much more politically powerful because earls sat in Parliament. The marriage of Duncan and Janet was a smart move for the Breadalbane Campbells and shows their growing strength.

Colin's alliances and connections in all directions increased the Breadalbane Campbells' wealth and influence. Since he did not like to travel, Grey Colin sent his son Black Duncan as emissary to Edinburgh where Duncan became good friends with James VI, the first Protestant king of Scotland.

During the 6th Laird's lifetime, in the mid to late 1500's, many Clan Campbell members joined the Reformation and converted to Protestantism. The clan chief, Lord Archibald Campbell, 4th Earl of Argyll, became a Presbyterian before he died in 1558. His son, the 5th Earl of Argyll and Colin's superior kinsman, was a devout Protestant who played an important role in the events involving Mary Queen of Scots. Colin's father-in-law William, Lord Ruthven, was an early Protestant supporter before he died in 1552.

Along with the majority of Scots, especially the Lowlanders and the townspeople, Colin and his other subordinate clansmen became followers of John Knox, the founder of Presbyterianism. Some clans (Erskines, Camerons, Oliphants) who had close contacts with the English joined the Church of England.

A significant number of the old Highland clans were more conservative and stayed Roman Catholic for some time (MacDonalds, MacLeans, MacGregors, Gordons). This set the Campbells at odds with several neighboring clans. Many Campbells were killed supporting their new faith and defending their holdings against raiding Catholic clans. There were atrocities and bad feelings on both sides for the next two centuries. Catholic neighbors even accused some Campbells of witchcraft.

The Campbells generally supported the Protestant Stewart kings while Scottish Highlander Catholics supported the exiled Stuarts (Jacobites) who were based in France and encouraged by Rome. But there were times in the early 1700's when some Campbells joined the Jacobites after the English picked George I, a "wee German lairdie" (little German squire), to be the King of Great Britain.

Many Campbells did well under the British kings after England and Scotland were united. Several became members of the Scottish branch of the British nobility. The Earls of Argyll moved up to become Dukes, the top ranking nobility, while Colin's descendants eventually became the Earls and then Marquesses of Breadalbane.

For the past 400 years, the British Army has recruited heavily from Clan Campbell and its associated families. At least 16 different Campbell-based Highlander regiments have moved up into the line of battle with their bagpipers playing "The Campbells Are Coming."

Colin Campbell, 6th Laird of Glenorchy and son of Sir George Campbell, was called Grey Colin for the color of his hair and beard. He expanded the power of his branch of Clan Campbell eastward through the Glens of Breadalbane and up against the land's of the Stewart Earls of Atholl in Perthshire. What better way to consolidate and secure his eastern borders than to arrange the marriage of his son 'Black' Duncan Campbell with Janet Stewart, daughter of the 4th Earl of Atholl?

In 16th Century Scotland, an earl was roughly two or three ranks above a laird and much more politically powerful because earls sat in Parliament. The marriage of Duncan and Janet was a smart move for the Breadalbane Campbells and shows their growing strength.

Colin's alliances and connections in all directions increased the Breadalbane Campbells' wealth and influence. Since he did not like to travel, Grey Colin sent his son Black Duncan as emissary to Edinburgh where Duncan became good friends with James VI, the first Protestant king of Scotland.

During the 6th Laird's lifetime, in the mid to late 1500's, many Clan Campbell members joined the Reformation and converted to Protestantism. The clan chief, Lord Archibald Campbell, 4th Earl of Argyll, became a Presbyterian before he died in 1558. His son, the 5th Earl of Argyll and Colin's superior kinsman, was a devout Protestant who played an important role in the events involving Mary Queen of Scots. Colin's father-in-law William, Lord Ruthven, was an early Protestant supporter before he died in 1552.

Along with the majority of Scots, especially the Lowlanders and the townspeople, Colin and his other subordinate clansmen became followers of John Knox, the founder of Presbyterianism. Some clans (Erskines, Camerons, Oliphants) who had close contacts with the English joined the Church of England.

A significant number of the old Highland clans were more conservative and stayed Roman Catholic for some time (MacDonalds, MacLeans, MacGregors, Gordons). This set the Campbells at odds with several neighboring clans. Many Campbells were killed supporting their new faith and defending their holdings against raiding Catholic clans. There were atrocities and bad feelings on both sides for the next two centuries. Catholic neighbors even accused some Campbells of witchcraft.

The Campbells generally supported the Protestant Stewart kings while Scottish Highlander Catholics supported the exiled Stuarts (Jacobites) who were based in France and encouraged by Rome. But there were times in the early 1700's when some Campbells joined the Jacobites after the English picked George I, a "wee German lairdie" (little German squire), to be the King of Great Britain.

Many Campbells did well under the British kings after England and Scotland were united. Several became members of the Scottish branch of the British nobility. The Earls of Argyll moved up to become Dukes, the top ranking nobility, while Colin's descendants eventually became the Earls and then Marquesses of Breadalbane.

For the past 400 years, the British Army has recruited heavily from Clan Campbell and its associated families. At least 16 different Campbell-based Highlander regiments have moved up into the line of battle with their bagpipers playing "The Campbells Are Coming."
